PANDUAN MENGISI BORANG PERMOHONAN MENDEPOSIT SEKURITI
INSTRUCTIONS FOR COMPLETION OF SECURITIES DEPOSIT REQUEST FORM

1. Borang ini hendaklah diisi dengan lengkap dalam tiga salinan. Gunakan borang yang berasingan bagi setiap sekuriti.
This form must be completed in triplicate. Use one form for each securities.
2. Sila taip atau tulis dengan menggunakan **HURUF BESAR**. Setiap kotak hendaklah mengandungi satu huruf sahaja.
*Please type or write using **BLOCK LETTERS**. Each box should contain only one letter.*
3. Setiap borang yang telah dilengkapkan perlu disertakan bersama sijil yang berkenaan dan Borang 32A.
Each completed form must be accompanied by the respective scrip and Form 32A.
4. Borang yang menunjukkan kesan dipadam atau sebarang jenis cecair pemadam boleh mengakibatkan permohonan ditolak.
Form defaced by erasure or any kind of correcting fluid may result in the application being rejected.
5. Sebarang pindaan yang dibuat diatas borang hendaklah mudah dibaca dan ditandatangani oleh pendeposit/penandatanganan diberi kuasa oleh pendeposit korporat.
Any amendment made on the form must be legible and countersigned by the depositor/authorised signatory(ies) of the corporate depositor.
6. Pendeposit akaun korporat perlu melekatkan Meterai Syarikat atau Cop Rasmi Syarikat.
Corporate account holder must affix either their common seal or company rubber-stamp.
7. Nombor rujukan deposit boleh digunakan untuk mengetahui status deposit anda dari ADA/ADM.
The deposit reference number can be used to enquire the status of your deposit from ADA/ADM.
